(A) An applicant for a firefighter certificate shall be at least eighteen years of age.

~~(A)~~(B) In addition to the requirement set forth in paragraph (A) of this rule, An applicant for a volunteer firefighter certificate shall satisfy all the following requirements to be eligible for certification:

(1) Shall successfully complete the following federal emergency management agency training courses:

(a) "National Incident Management System Course IS-700";

(b) "National Incident Management System Course ICS-100" or the online equivalent.

~~(1) Submit a completed application, "Firefighter or Fire Safety Inspector Initial Application";~~

~~(2) Successfully~~Shall successfully complete a volunteer firefighter training course through a chartered program, and receive a ~~document~~certificate of course completion at the volunteer firefighter level ~~for which the certificate of firefighter training is sought;~~

~~(3) Pass~~Shall pass the knowledge and practical skills examinations as set forth in rule 4765-20-06 of the Administrative Code within one hundred eighty days of volunteer firefighter training course completion;

~~(4) Be at least eighteen years of age;~~

~~(5) Has not been convicted of any of the following:~~

(4) Shall submit a completed "Firefighter, Fire Safety Inspector, or Hazard Recognition Officer Initial Application" within ninety days of passing the knowledge examination.

(C) The requirements listed in paragraphs (B)(1) to (B)(3) of this rule shall be completed prior to submission of a completed "Firefighter, Fire Safety Inspector, or Hazard Recognition Officer Initial Application."

(D) In addition to the requirement set forth in paragraph (A) of this rule, an applicant for a firefighter I or firefighter II certificate shall satisfy all of the following requirements to be eligible for certification:

(1) Shall successfully complete the following federal emergency management agency training courses:

(a) "National Incident Management System Course IS-700";

(b) "National Incident Management System Course ICS-100" or the online equivalent.

(2) Shall successfully complete a firefighter I or firefighter II training course through a chartered program and receive a certificate of course completion at the level for which the certificate of firefighter training is sought;

(3) Shall meet the objectives as set forth in "Emergency Vehicle Operations Course Objectives" as approved by the executive director, with advice and counsel of the committee, and meeting the following:

(a) The course shall consist of a minimum of sixteen hours;

(b) The course shall be consistent with the intent of "NFPA 1002" and "NFPA 1451" and shall meet the course objectives as approved by the executive director, with advice and counsel of the committee;

(4) Shall successfully complete hazardous materials awareness and operations level training in accordance with the following:

(a) The training shall consist of a minimum of twenty-four hours;

(b) The training shall meet the mission-specific competencies specified in "NFPA 1072" as required by "NFPA 1001";

- (c) The training shall meet the objectives as set forth in the "Hazardous Materials Awareness and Operations Course Objectives" approved by the executive director, with advice and counsel of the committee;
- (5) Shall successfully complete emergency medical care training in accordance with the following:
- (a) The training shall consist of a minimum of eight hours;
- (b) The training shall meet the performance capabilities specified in "NFPA 1001" chapter 4.3.
- (6) Shall pass the knowledge and practical skills examinations as set forth in rule 4765-20-06 of the Administrative Code within one hundred eighty days of firefighter I or firefighter II training course completion;
- (7) Shall submit a completed "Firefighter, Fire Safety Inspector, or Hazard Recognition Officer Initial Application" within ninety days of passing the knowledge examination;
- (E) The requirements listed in paragraphs (D)(1) to (D)(6) of this rule shall be completed prior to submission of a completed "Firefighter, Fire Safety Inspector, or Hazard Recognition Officer Initial Application":
- (F) In addition to the requirements set forth in paragraphs (A) to (E) of this rule, as applicable, an applicant for firefighter:
- (1) Shall not have been convicted of any of the following:
- (a) Any felony;
- (b) A misdemeanor committed in the course of practice;
- (c) A misdemeanor involving moral turpitude.
- (2) Shall not have committed fraud, misrepresentation, or material deception in applying for or obtaining a certificate issued under section 4765.55 of the Revised Code and this chapter.
- (3) Shall not have been previously revoked or denied a certificate by the executive director or the licensing organization in another state.
- ~~(B)~~(G) In deciding whether to grant a firefighter certificate, the executive director, with the advice and counsel of the committee, has the following options:

- (1) The executive director shall issue a firefighter certificate to an applicant who meets all of the requirements listed in paragraphs ~~(A)(1)(A)~~ to ~~(A)(6)(F)~~ of this rule, as applicable;
- (2) The executive director shall refuse to grant a firefighter certificate to an applicant who fails to meet one or more of the requirements listed in paragraphs ~~(A)(1)(A)~~ to ~~(A)(4)(E)~~ of this rule, as applicable;
- (3) The executive director may grant, refuse to grant, or restrict a firefighter certificate to an applicant who meets the requirements listed in paragraphs ~~(A)(1)(A)~~ to ~~(A)(4)(E)~~ of this rule, as applicable, but fails to meet one or more of the requirements listed in paragraphs ~~(A)(5)~~ to ~~(A)(6)~~ paragraph (F) of this rule.

(H) Credit shall be given for successful completion of the emergency vehicle operations course specified in paragraph (D) of this rule if all of the following are met:

- (1) The training is recognized by the program director of a chartered program;
- (2) The training meets or exceeds sixteen hours;
- (3) The training meets the current course objectives as approved by the executive director; and
- (4) The training was completed not more than twelve months prior to the firefighter training course start date.

(I) Credit may be given for successful completion of hazardous materials awareness and operations level training specified in paragraph (D) of this rule if all of the following are met:

- (1) The training is recognized by the program director of a chartered program;
- (2) The training meets or exceeds twenty-four hours;
- (3) The training meets the "Hazardous Materials Awareness and Operations Course Objectives" approved by the executive director.

(J) Credit shall be given for successful completion of hazardous materials awareness and operations level training specified in paragraph (D) of this rule if the training was completed as part of an Ohio firefighter I training course.

(K) Credit shall be given for successful completion of emergency medical care training as set forth in paragraph (D) of this rule if the training meets or exceeds eight hours and any of the following apply:

(1) The training resulted in certification as an Ohio emergency medical responder;

(2) The training resulted in certification as an Ohio emergency medical technician;

(3) The training resulted in certification as an Ohio paramedic.

~~(C)~~(L) No person shall hold a firefighter certificate at more than one level.

~~(D)~~ In addition to the requirements set forth in paragraphs (A)(1) to (A)(6) of this rule, an applicant for a firefighter certificate shall successfully complete the following "Federal Emergency Management Agency" training courses:

~~(1) "National Incident Management System Course IS-700";~~

~~(2) "National Incident Management System Course ICS-100" or the online equivalent.~~

~~(E)~~ In addition to meeting the requirements set forth in paragraphs (A)(1) to (A)(6) and (D) of this rule, an applicant for a firefighter I or firefighter II certificate shall have successfully completed training on "NFPA standard 472" related to the minimum requirements in terms of professional core competencies for hazardous materials awareness and operations.

(A) An applicant for a fire safety inspector certificate shall satisfy the following requirements:

(1) Shall be at least eighteen years of age;

(2) Shall possess a current and valid firefighter certificate that is in good standing;

(3) Shall successfully complete a fire safety inspector training course through a chartered program and receive a certificate of course completion;

(4) Shall pass the knowledge and practical skills examinations as set forth in rule 4765-20-06 of the Administrative Code within one hundred eighty days of fire safety inspector course completion;

(5) Shall submit a completed "Firefighter, Fire Safety Inspector, or Hazard Recognition Officer Initial Application" within ninety days of passing the knowledge examination.

(B) An applicant for a hazard recognition officer certificate shall satisfy the following requirements:

(1) Shall be at least eighteen years of age;

(2) Shall possess a current and valid firefighter certificate that is in good standing;

(3) Shall successfully complete a hazard recognition officer training course through a chartered program, and receive a certificate of course completion;

(4) Shall pass the knowledge examination as set forth in rule 4765-20-06 of the Administrative Code within ninety days of hazard recognition officer training course completion;

(2) The executive director shall refuse to grant a hazard recognition officer certificate of training to an applicant who fails to meet one or more of the requirements listed in paragraphs (B), (C), or (D) of this rule;

(3) The executive director may grant, refuse to grant, or restrict a hazard recognition officer certificate of training to an applicant who meets the requirements listed in paragraphs (B) and (C) of this rule, but fails to meet one or more of the requirements listed in paragraph (D) of this rule.

- (A) An applicant for a firefighter, fire safety inspector or instructor certificate shall submit a completed "Firefighter or Fire Safety Inspector Initial Application," or "Fire, Assistant Fire and/or Fire Safety Inspector Instructor Initial Application."
- (B) An application that is not filled out in the manner as specified may be deemed incomplete.
- (C) An applicant who has been convicted of any offense listed in rules 4765-20-02, 4765-20-03 and 4765-21-03 of the Administrative Code shall, at the applicant's expense, submit with the application a certified copy of the judgment entry from the court in which the conviction occurred, a civilian background check from the bureau of criminal identification and investigation (BCI&I), and a certified copy of the police report or law enforcement agency report, if applicable. Subject to the discretion of the executive director, failure to submit this documentation may render the application incomplete.
- (D) Applications deemed incomplete shall not be considered. The division shall provide written notification to the applicant indicating the reason the application is incomplete.

(A) An applicant for a firefighter, fire safety inspector, or hazard recognition officer certificate shall submit a completed "Firefighter, Fire Safety Inspector, or Hazard Recognition Officer Initial Application."

(B) An applicant for renewal of a firefighter, fire safety inspector, or hazard recognition officer certificate shall submit a completed "Firefighter, Fire Safety Inspector, or Hazard Recognition Officer Renewal Application."

(C) An applicant requesting reinstatement of a firefighter, fire safety inspector, or hazard recognition officer certificate shall submit a completed "Firefighter, Fire Safety Inspector, and/or Hazard Recognition Officer Reinstatement Application."

(D) An applicant requesting certification as a firefighter through reciprocity shall submit a completed "Firefighter Reciprocity Application."

(E) An application that is not filled out in the manner specified may be deemed incomplete by the executive director. Incomplete applications will not be considered by the executive director.

(F) At the time of application, an applicant who has been convicted of any criminal offense other than a minor traffic offense, shall at the applicant's expense submit the following with the application:

(1) A certified copy of the judgment entry from the court in which the conviction occurred;

(2) A civilian background check from the bureau of criminal identification and investigation (BCI&I); and

(3) A certified copy of the police report or law enforcement agency report, if applicable.

(G) Subject to the discretion of the executive director, failure to submit documentation required in paragraph (F) of this rule may render the application incomplete.

(H) Armed forces applications are processed as follows:

(1) The division shall track and monitor each application for a certificate that has been received from an applicant who is a:

(a) Veteran;

(b) Member of the armed forces;

(c) Spouse of a veteran or member of the armed forces; or

(d) Surviving spouse of a veteran or member of the armed forces.

(2) The division shall prioritize and expedite each completed initial application and renewal application received from an applicant who is a:

(a) Veteran;

(b) Member of the armed forces;

(c) Spouse of a veteran or member of the armed forces; or

(d) Surviving spouse of a veteran or member of the armed forces.

(3) In order to expedite the processing of completed applications and renewals, especially for individuals facing imminent deployment, the division shall accept necessary information in support of the application by electronic and other appropriate means.

(A) The initial examinations required for a firefighter certificate shall consist of a knowledge examination and a practical skills examination ~~established~~ as approved by the executive director, with the advice and counsel of the committee.

(1) The knowledge examination for a firefighter certificate shall meet the following:

- (a) The knowledge examination shall be taken at the level of firefighter certification sought;
- (b) A passing score of at least seventy per cent on the knowledge examination is required for certification;
- (c) The knowledge examination required for certification shall be passed within three attempts;

(A) For purposes of granting reciprocity, the executive director may review firefighter licensing or certification requirements and firefighter training standards from another state, the District of Columbia, a United States territory, any branch of the United States military, or other firefighter training program approved by the executive director to identify those requirements and standards that are substantially similar to the curriculum and certification standards as set forth in Chapter 4765-24 of the Administrative Code and this chapter.

(B) In accordance with section 5903.03 of the Revised Code the division shall consider substantially similar military experience, education, and training when determining whether an applicant who is a veteran or member of the armed forces has met all or part of the requirements for a certificate. An applicant who is a veteran or member of the armed forces shall provide all relevant documentation demonstrating his or her military experience, education, and training to assist the division in its determination.

(C) The executive director shall issue a firefighter certificate through reciprocity pursuant to section 4765.55 of the Revised Code and this chapter, to an applicant who holds a current and valid firefighter certificate or license, that is in good standing, from another state, the District of Columbia, or a United States territory provided that the applicant meets all of the following:

(1) The applicant is at least eighteen years of age;

(2) The applicant shall have successfully completed the following federal emergency management agency training courses:

(a) "National Incident Management System Course IS-700";

(b) "National Incident Management System Course ICS-100" or the online equivalent.

(3) The applicant shall have successfully completed a structured firefighter training course in another state, the District of Columbia, a United States territory, or other fire training program approved by the executive director that is substantially similar to the training standards and curriculum as set forth in Chapter 4765-24 of the Administrative Code. Firefighter continuing education.

(A) An applicant who wishes to renew a firefighter certificate shall have completed fifty-four hours of continuing education within the current three-year certification cycle that is related to the fire service and approved by the applicant's fire chief or program director of a chartered program. Such continuing education courses may be completed through in-service training programs conducted by the applicant's affiliated fire department;

(B) An applicant who is participating in a firefighter training course to attain a higher level of firefighter certification may count the hours toward the requirements in paragraph (A) of this rule.

(C) An out-of-state applicant or an applicant unaffiliated with an Ohio fire department has the following options for meeting the continuing education requirements as set forth in this rule:

(1) An applicant that resides in Ohio, but is not affiliated with an Ohio fire department, may complete continuing education through the following:

(a) Training approved by the applicant's fire chief;

(b) Continuing education training approved by a program director of a chartered program;

(c) Fire service training received by any other entity approved by the executive director, including but not limited to, the following entities:

(i) national fire academy;

(ii) fire department instructors conference;

(iii) fire-rescue international;

(iv) national domestic preparedness consortium.

(2) An applicant that does not reside in Ohio and is not affiliated with an Ohio fire department may complete continuing education through the following:

(a) Training approved by the applicant's fire chief;

(b) Training from a fire training institution approved by the licensing agency in another state;

(c) Training received by any other entity approved by the executive director, including but not limited to the following entities:

(i) National fire academy;

(ii) Fire department instructors conference;

(iii) Fire-rescue international;

(iv) National domestic preparedness consortium.

(3) Documentation of course completion shall be kept by the applicant.

(D) Routine duties to include but not limited to responding to emergencies, performing station duties and vehicle maintenance, conducting fire safety inspections, participating in civic events, and other daily or weekly job duties shall not be credited toward firefighter continuing education.

(E) No applicant shall receive credit for more than twelve hours of continuing education training in any one calendar day.

(F) No applicant shall receive continuing education credit for the identical online training class, taken more than once per calendar year.

(G) Extension of time to complete firefighter continuing education shall be permitted as set forth in rule 4765-20-13 of the Administrative Code.

(H) Credit for continuing education received during the period of an extension, up to and including the date the renewal application is submitted, shall not be used as credit for continuing education in the subsequent certification cycle.

(I) The holder of a firefighter certificate shall maintain records of continuing education required by this rule for the current and previous certification cycles.

(1) Such records shall include the course title, date, hours claimed, and who provided the training.

(2) Upon request, documentation shall be provided to the division within the time parameters set forth by the executive director.

(J) For the purpose of continuing education approval, fire chief means a certified firefighter who has been designated as the head of a fire department or private firefighting brigade.

(K) Military provisions related to firefighter continuing education:

- (1) The division shall consider relevant education, training, or service completed by the certificate holder as a member of the armed forces in determining whether the certificate holder has fulfilled required continuing education.
 - (2) In accordance with section 5903.12 of the Revised Code and this chapter of the Administrative Code, a certificate holder who has served on active duty during the current or prior certification cycle may request an extension of time to complete the current continuing education as set forth in rule 4765-20-13 of the Administrative Code.

 - (9) Basic electrical equipment and wiring hazards; and
 - (10) Other training directly related to performance of hazard recognition officer duties.
- (E) If a new fire code is adopted by the state of Ohio, a fire safety inspector and hazard recognition officer shall attend continuing education of not less than four hours related to the new fire code. The continuing education shall be completed within six months of the adoption of the new fire code. The fire safety inspector shall maintain documentation of completion of this update. These four hours may be counted towards the requirements set forth in paragraph (A) of this rule.
- (F) Fire safety inspector and hazard recognition officer continuing education shall be provided by or under the auspices of institutions of higher education, recognized state agencies, chartered training programs, fire schools, fire training academies, or a fire department operated by federal, state, county, or local government, or non-profit organizations.
- (G) Routine duties such as responding to emergencies, performing station duties and vehicle maintenance, conducting fire safety inspections, participating in civic events, and other daily or weekly job duties shall not be credited toward fire safety inspector and hazard recognition officer continuing education.
- (H) No applicant shall receive credit for more than twelve hours of continuing education training in any one calendar day.
- (I) No applicant shall receive continuing education credit for the identical online training class, taken more than once per calendar year.
- (J) Extension of time to complete fire safety inspector continuing education shall be permitted as set forth in rule 4765-20-13 of the Administrative Code.
- (K) Extension of time to complete hazard recognition officer continuing education is not permitted.

(L) Credit for continuing education received during the period of an extension, up to and including the date the renewal application is submitted, shall not be used as credit for continuing education in the subsequent certification cycle.

(M) The holder of a fire safety inspector certificate shall maintain records of continuing education required by this rule for the current and previous certification cycles.

(1) Such records shall include the course title, date, hours claimed, and who provided the training.

(2) Upon request, documentation shall be provided to the division within the time parameters set forth by the executive director.

(N) For the purpose of continuing education approval, fire chief means a certified firefighter who has been designated as the head of a fire department or private firefighting brigade.

(O) Military provisions related to fire safety inspector continuing education:

(1) The division shall consider relevant education, training, or service completed by the certificate holder as a member of the armed forces in determining whether the certificate holder has fulfilled required continuing education.

(2) In accordance with section 5903.12 of the Revised Code and this chapter of the Administrative Code, a certificate holder who has served on active duty during the current or prior certification cycle may request an extension of time to complete the current continuing education as set forth in rule 4765-20-13 of the Administrative Code.

(3) All provisions of paragraph (O) of this rule shall apply to any certificate holder who is the spouse of a person who has served on active duty when that service resulted in the certificate holder's absence from this state.

(P) An applicant for renewal who has a fire safety inspector or hazard recognition officer certification cycle that is less than thirty-six months shall complete the pro-rated continuing education requirements as set forth in rule 4765-20-16 of the Administrative Code.

(B) A ninety-day functioning extension may be granted by the executive director to the holder of a firefighter, fire safety inspector, or hazard recognition officer certificate that submits a "Request for Extension of Fire Certificates" form if either of the following conditions are met:

(1) The request is received prior to the expiration date of the certificate;

(2) The request is received no more than ninety days after the expiration date of the certificate and there are extenuating circumstances, deemed acceptable by the executive director, that prevented the submission of the request for an extension prior to the expiration of the certificate.

(C) The executive director, with advice and counsel of the committee, may grant an extension for a period of greater than ninety days if it is determined there are extenuating circumstances affecting the ability of the certificate holder to comply with the continuing education requirement within ninety days of the expiration of the certificate to practice.

(1) The executive director shall have full discretion in determining the length of the extension and whether, or to what extent, the holder of the lapsed certificate may engage in activities for which a certificate to practice is otherwise required.

(2) A holder of a firefighter, fire safety inspector, or hazard recognition officer certificate seeking an extension for a period of greater than ninety days shall submit a written request to the division which shall include all of the following:

(a) Length of extension requested;

(b) Justification for the extension;

(c) The amount and type of continuing education needed to comply with the requirement for renewal of the firefighter, fire safety inspector, or hazard recognition officer certificate;

(d) A specific plan for completion of the continuing education requirement within the length of time requested;

(e) Certification number of the firefighter, fire safety inspector, or hazard recognition officer certificate;

(f) Signature of the certificate holder.

(D) The holder of a firefighter, fire safety inspector, or hazard recognition officer certificate that is granted an extension pursuant to this rule shall complete the continuing education requirement and submit a "Firefighter, Fire Safety Inspector, or Hazard Recognition Officer Renewal Application," no later than the expiration date of the granted extension.

(E) The holder of a firefighter, fire safety inspector, or hazard recognition officer certificate that is granted an extension pursuant to this rule shall be audited for compliance with continuing education requirements upon renewal of the certificate.

(F) Military provisions related to extension of time to complete firefighter, fire safety inspector, or hazard recognition officer continuing education:

(1) In accordance with section 5903.12 of the Revised Code and this chapter of the Administrative Code, a certificate holder who has served on active duty during the current or prior certification cycle may request an extension of time to complete the current continuing education or instructional renewal requirement, if both of the following conditions are met:

(a) The certificate holder submits documentation to the division stating that the certificate holder requires the extension of the current certification cycle because the certificate holder has served on active duty during the current or prior certification cycle.

(b) The documentation submitted certifies the active duty service and the length of that active duty service as a period in excess of thirty-one days during the current or prior continuing education or instructional renewal certification cycle.

(2) Upon the division's receipt of satisfactory evidence of service, in accordance with section 5903.12 of the Revised Code, the division shall extend the current continuing education or instructional renewal certification cycle by an amount of time equal to the total number of months that the certificate holder spent on active duty service during the current certification cycle. Any portion of a month served shall be considered one full month.

(3) All provisions of paragraph (F) of this rule shall apply to any certificate holder who is the spouse of a person who has served on active duty when that service resulted in the certificate holder's absence from this state.

(1) An applicant that resides in Ohio, but is not affiliated with an Ohio fire department, may complete continuing education through the following:

(a) Training approved by the applicant's fire chief;

(b) Continuing education courses approved by a program director of a chartered program;

(c) Fire service training received by any other entity approved by the executive director, including but not limited to, the following entities:

(i) "National Fire Academy";

(ii) "Fire Department Instructors Conference";

(iii) "Fire-Rescue International";

(iv) "National Domestic Preparedness Consortium."

(2) An applicant that does not reside in Ohio and is not affiliated with an Ohio fire department may complete continuing education through the following:

(a) Training approved by the applicant's fire chief;

(b) Training from a fire training institution approved by the licensing agency in another state;

(c) Training received by any other entity approved by the executive director, including but not limited to the following entities:

 - (4) Thirty-six months or more, fifty-four hours of continuing education is required.
- (D) Except as provided in paragraph (E) of this rule, a fire safety inspector certificate shall expire on the same date as the individual's firefighter certification, or on the individual's date of birth in the third year if the individual does not possess a current firefighter certificate. In order to be eligible to renew the fire safety inspector certificate, the individual shall complete continuing education, in accordance with rule 4765-20-16 of the Administrative Code, for a reduced amount of hours according to the length of the certification cycle.
- (E) A fire safety inspector certificate issued to an individual who also holds a current EMS provider certificate to practice, but does not hold a firefighter certificate, shall expire on the same date as the EMS provider's certificate to practice. In order to be eligible to renew the fire safety inspector certificate, the individual shall complete continuing

education, in accordance with rule 4765-20-16 of the Administrative Code, for the following reduced hours and certification cycle:

- (1) Twelve months or less, no continuing education is required;
- (2) More than twelve months but less than twenty-four months, ten hours of continuing education is required;
- (3) Twenty-four months but less than thirty-six months, twenty hours of continuing education is required;
- (4) Thirty-six months or more, thirty hours of continuing education is required.

(F) A fire instructor or fire safety inspector instructor certificate shall expire on the same date as the individual's firefighter certification, or fire safety inspector certificate if the individual does not hold a current firefighter certificate. In order to be eligible to renew the instructor certificate, the individual shall complete continuing education, in accordance with rule 4765-21-04 of the Administrative Code, for the following reduced hours and certification cycle:

- (1) Twelve months or less, no continuing education or instruction of a fire service training or continuing education program is required
- (2) More than twelve months but less than twenty-four months, two hours of continuing education and eight hours of instruction of a fire service training or continuing education program is required;
- (3) Twenty-four months but less than thirty-six months, four hours of continuing education and sixteen hours of instruction of a fire service training or continuing education program is required;
- (4) Thirty-six months or more, six hours of continuing education and twenty-four hours of instruction of a fire service training or continuing education program is required.

(G) An assistant fire instructor certificate shall expire on the same date as the individual's firefighter certification. In order to be eligible to renew the assistant fire instructor certificate, the individual shall complete continuing education, in accordance with rule 4765-21-04 of the Administrative Code, for the following reduced hours and certification cycle:

- (1) Twelve months or less, no continuing education or instruction of a fire service training or continuing education program is required;

- (2) More than twelve months but less than twenty-four months, two hours of continuing education and two hours of instruction of a fire service training or continuing education program is required;
 - (3) Twenty-four months but less than thirty-six months, three hours of continuing education and four hours of instruction of a fire service training or continuing education program is required;
 - (4) Thirty-six months or more, six hours of continuing education and eight hours of instruction of a fire service training or continuing education program is required.
- (H) Once a mutual expiration date is established for all EMS and fire certificates, all certificates will be issued a three-year certification cycle and shall expire on the individual's date of birth in the third year.
- (I) Once a mutual expiration date is established for all EMS and fire certificates, the expiration date will not be changed and any newly obtained certificate will be assigned the current expiration date in accordance with this rule and a shortened certification cycle for the newly issued certificate.
